

STOP! The violence over the children



The First Children's Embassy in the World – Megjashi

started the campaign STOP! The violence against children in Ma-

cedonia.

The main reason for starting this campaign was the recent maltreating of two children to almost dead, as well as the increased number of phone calls on our helpline (0800 1 2222) for children and youth.

The aim of the campaign was to send the message to everyone, keep and protect the children from every type of violence and provide them with safe life, because they are our future.

The 15 billboards can be seen around the centre of the city Skopje for one month, with two different messages:

"STOP! To the violence against children!" and

"Have you hugged your child today?".

Special thanks to Akzent Media for the free billboards.

"Have you hugged your child today?" is one of the two messages on the billboards in our city.

The main purpose of this message, as well as the second one,

STOP! To the violence against children!", is to attract the attention of the adults to give more love and attention to children, especially because the dynamic pace of our occupation does not leave much room for that.

The Violence against children is more and more present!!! The case in Cicino Selo

On **15.12.2006**, a press conference took place in the premises of Embassy Megjashi, the reason for which was the beating of the 3 year-old **Amid Mekteshi from Cicino Selo** (village).

The child was beaten up with fists and kicks by his mother's wedlock partner. The incident happened in "Mladost" resort in Cicino Selo, Skopje , where the refugees from the Kosovo conflict in 1999 are located.

The child was in critical condition and was transfered in the Clinic for Surgery for children diseases. The police was informed about the case.

This is one of the numerous reported cases for violence against children.

This case was the main reason

15th anniversary of First Children's Embassy in the World—Megjashi

This year is very special for the Embassy Megjashi because on 29 April, 2007, the Embassy is celebrating its 15 anniversary.

The Embassy Megjashi for the past 15 years advocated respect of children's personality through protecting their rights and interests, as well as enrichment of their lives with contents which are safe and creative for their childhood.

The embassy with its activities made a huge progress in raising

of the public awareness about children's rights. It broke the wall of silence about children's suffering ,especially physical , sexual and economical abuse of children , revealing to the public many cases of child abuse and establishing directly efficient measures for protection of the children.

In the last **15 years** significant results have been achieved , and the most important are taking care for the children refugees during the crisis in Bosnia

and Herzegovina , Kosovo and Macedonia, launching the children's workshops and the free helpline for children and youth , psychological advice service , the campaign for protecting children rights , prevention of violence against children, free legal assistance, as well as numerous activities which will be mentioned in the monograph which is in process, and which will be published for the 15 anniversary.

Donation of shoes for children without parents

The First Children's Embassy in the World—Megjashi in cooperation with the company NELT ST DOOEL Skopje and SSL producer on Dr. Scholl, organize action donation of shoes for the children in the orphanages in Skopje.

The main initiator was the firm **NELT ST** from Skopje , which we cooperate with for years. They provided **288 pairs of shoes**

for the children with lack of parental care in the Orphanage "11 October", the orphanage for children with educational and social problems "25 May", for children from Institute for housing, education and behavior, "Ranka Milanovik" and for families from Aracinovo that were housed 5 years at the premises in Children's Embassy Megjashi.

Except shoes, medical aid from the production program **Dr.School** was donated to the Clinic for surgery in Skopje. The shoes and aid resources are productions from repute firm **SSI**, the donation cost **2.370.000,00** denars.

Activities from the children's workshops

Besides visiting the workshops, the First children's embassy conducted different activities in which the children, their parents, volunteers, and the personnel in Children's Embassy were included.

On 2 December 2006, an educational and recreational excursion to Vodno was organized with activities such as roller-blades competition; short lecture on environmental issues and the necessary activities to prevent them; presence on manifestation for extinguishing of fire, planting green trees in nature; in organization with the Red Cross in Macedonia.

On 17-december we organized visit on Planetarium .



On 19 December the children who attended the English workshop visited the American Corner on the so called Day of Storytelling.

On 27 December New Year celebration party was organized

and masquerade for all children members attending the Children's workshops.

The children wore beautiful costumes and the party took place in the children's club Fantazija.

SOS (helpline) for children and young 0800 1 2222

SOS helpline for children and young in the First Children's Embassy is the first free helpline for children and young in this country , which in continuity function almost 14 years (from 1993).

The great number of problems that the young people confront often are related with violence (physical, sexually and psychological), problems in the family, with friends, a love live, personally problems and others problems.

This is one example for such a case: one our citizen called to reported that the father of their sister's wife wants to wed her

even she is 13 years old with the boy who is 28.

The boy offered money allowance and because of that the father wants to wed his daughter without her permission. The case was reported in Centre of social affairs and the procedure is in flow.

In the period from 1 January 2006 to 31 December 2006 we got 704 calls on the SOS helpline (080012222) for children and young.

About **514 (73%)** are female and **190 (27%)**



are male.

According to percentage dullness of phone calls on SOS phone on the first place is Skopje, than Prilep, Veles, Bitola and residua towns.

The SOS phone is financial supported by Macedonian Tele... and SOS phone from Irish.



Some of the cases of violation of chidren's rights

1.Cases of physical violence over children by their professor in an Children's Home, for which we wrote in the last issue.

Because of the deficit of information for the names of the children we couldn't identify the respective Centre responsible for these children.

We've sent a letter for additional information to the Police Station in Chair, where the case was originally reported. Although we were informed by the caller that the police made minutes on the scene, still the police station says that such case was never reported to them. Also, the Ombudsman can't lead an investigation in front of the investigatory Instructions, because the person wanted to stay anonymous.

Therefore, we must close this case.

Displeasure of the students for the HR policy of the Director of the School.

A group of students from elementary school sent a letter in which they stated displeasure for the HR policy of the Director of the School.

Namely, the children find that part of the professors don't have the necessary education on their subject and that hey teach using old methods in otherwise bad material conditions of the school.

We have reported this case to the Ombudsman.

Further on, they reported the case to the State Inspectorate for Labor due to supervision on procedures for employment of teachers in the elementary schools, in accordance with the Law for working relations and the Law for elementary education.

There are ongoing inspectorates for this case, and we are awaiting information from the Ombudsman.

3. The case on which there were indications that there is mediation for prostitution on minor with an older male for which we have already written in the previous issue.

The case was regularly reported directly in the Ministry of Internal Affairs in the department for Trafficking and Violent Crime.

After the conversations with the pedagogue of the School, we have found out that the person was apparent by the authorities from the respective department.

After the successful completion of the investigation in the Investigatory Court, the suspect was sentenced with 5 years in prizon for the action Mediation in prostitution of minors.

4.A Case of groundless written sentence.

This case was reported by parents of a second-year high school student. The child was accused from other students fro selling marijuana in the school. Although there wasn't enough evidence for this, the teacher collegiums of the school punished the student with written sentence before expulsion.

The parents subjected the child for medical exams, on which base was confirmed that he haven't been using any kind of narcotics.

With this, the reputation of the student was changed also presents violation of the Convention for protection of children's rights, article 29, which states that the education of the child should be focused towards the development of the child's personality.

Furthermore, this threw additional psychological weight over the student.

Afterwards, an appeal to the Ombudsman was sent, who continued to take measures from his jurisdiction of protection of children's rights.

On this workshop, representatives from many civic organizations were present, among which were the representatives of the Children's Embassy Megjashi.

Expert-guests were Mr. Slavko Lazovksi, representative from the ministry of Finance and Mr. Borce Smilevski, representative from the Audit House KPMG, which explained the benefits that will follow the implementation of this Law.
